Requests for Special Permission to leave, entre, or travel within South Sudan,

1-Grant permission Relief International staff for Mr. Micheal Atem to travel from Juba to Maban on 7th May, 2020 and must be tested for COVID – 19 prior to departure.

2-Grant permission for IRC to transport 50 Metallic drums of diesel fuel and 50 empty metallic drums from Rumbek, Lake State to Koch, Unity State between 7th – 30th May, 2020. All drivers must be tested for COVID-19 prior travel.


